

DIY Will Kits

Butler Wills and Estates has provided us with another informative article - on "DIY Will Kits". We have all heard about them but few of us know exactly how they work. Thank-you Lynn and Chelsea! Read on!

Are DIY Will Kits a Good Idea?

These days will kits are available everywhere. With a few clicks on your computer you can find a wide variety of options for writing your will at home without needing to contact a lawyer. Of course, quantity does not always equal quality, and making a will is something that can go terribly wrong if done incorrectly. Does this mean that you absolutely have to call a lawyer to have your will made? Perhaps. Let's take a closer look at the pros and cons of using a do-it-yourself will kit in comparison to working with a lawyer.

• Cost: Whether you purchase your will kit online or in a store, the vast majority of kits are extremely inexpensive. Some online versions are even free when you sign up for the website subscription list. This is a huge factor for a lot of people who want to make a will, but who don't have a lot of spare income. Some online kits offer to have your document

reviewed by a professional for an extra fee. Often, this fee is a couple hundred dollars, but it isn't mandatory if a consumer wants to use the kit.

In comparison, a lawyer will likely charge at least a few hundred dollars for a will. This can be a big purchase for seniors on a fixed income, or young families with a lot of expenses. There is no fixed price for a will from one lawyer to the next, and many will charge based on how long the process will take and how complicated the situation is.

• Ease of Access: Consumers can purchase a will kit just about anywhere. Bookstores carry them, as do office supply stores. You can also download forms from the Internet, or use a program on a website. Since the user can complete the kit at any time in any location, kits are pretty easy to use. Kits come with instructions about how to fill them in, but there isn't usually anything included to tell you what to do if you are in a situation that is not covered by the kit. Paper versions of kits also most likely don't provide the consumer with resources for help.

To get a will done by a lawyer, you need to schedule an appointment. Chances are good you will need to go to their office, although more and more lawyers are visiting clients in their homes if the client is not mobile. Unlike a will kit, the lawyer will create the documents for you, and explain everything that is involved including why certain things should or should not be included, and what the repercussions of those decisions are. If you go to an experienced estates lawyer, you can be sure that he or she will be able to provide you with a document that does everything you need it to.

What You Get: What the consumer gets
with a will kit is fairly straightforward
 - the kit gives you a document labelled
"Last Will and Testament". The document itself will also be straightforward
and simple since an algorithm or fill-inthe-blank booklet cannot account for every likely scenario for each person. A kit
will provide the consumer with this one
document and nothing else.

The sum of what you get with a lawyer is more than just the document itself. You will also receive personalized advice, information about potential pitfalls you may not have thought of, and a document that is tailored to your specific situation. An experienced estate lawyer will also discuss with you the option of having a complete estate plan rather than just a will.

• Down the Road: Will kits provide you with a template will that the consumer plugs their information into. For extremely simple situations (i.e. no investments or rental properties, no blended families, no dependents with a disability, and no lists of individual gifts) this document may be sufficient.

However, if your situation is even slightly

more complicated, a kit may not be the best choice. Problems with an estate arise after the person has passed away, when it is too late for them to explain what they want. This leaves family members to fight over what each of them thinks the person wanted. If you have not properly explained what you want in your will, and given your executor the appropriate legal powers to make it happen, a will can be worse than useless.

Wills that are made by lawyers can still be fought over. However, a lawyer will have thorough notes about what the person said, and what they wanted, and include all the necessary powers for an executor.

Is the Kit a Good Idea? If your situation is extremely simple, a will kit might work Unfortunately, you wouldn't for you. know whether or not your will was being fought over. If you want to consider using a will kit, look for reviews of each kit online. The reviews on the company website will be positive in order to encourage sales, so check for reviews elsewhere, like a legal blog that is not sponsored. Some of the key things to look for include whether or not the kit is legal in all provinces, who wrote the kit and whether or not they are a lawyer, and how much information the users of the kit were able to customize in the document.

For people who are in situations that are more complicated than extremely basic, consider meeting with a lawyer to get a will done. Do your research before you book an appointment to find out things like what the price will be, how long it will take, and what is included. If you are concerned about the fee, you can also ask whether or not the lawyer is willing to offer a payment plan.

Susan Kielley, Scotia McLeod, has provided an excellent article on RRSP Contributions for those who will turn 71. Yet another reason to have a financial adviser who can guide you through the maze! Read on!

One last chance for an RRSP contribution

Individuals turning 71 must wind down their RRSPs by the end of the year in which

they turn 71. This means that they must transfer the assets in their RRSP to a RRIF, purchase an annuity, simply withdraw or cash in the assets, or any combination of these options.

Getting around the rules - one more contribution

There is a way for someone falling under the new rules to contribute once more to their RRSP. To do this, they must have earned income during 2018 that would otherwise give them the ability to contribute to an RRSP during 2019, even though they will not be allowed to have one. The new rules also introduced carry forward rules that allow someone to make an RRSP contribution and deduct it in the future. Therefore, the way they get the contribution into their RRSP is to make an over contribution during the month of December 2018.

Example

John turns 71 this year and must wind down his RRSP by the end of the year. However, John is a doctor and still works parttime meaning he has earned income. His income levels would allow him to make a \$25,370 RRSP contribution next year. Because John has to wind down his RRSP, he cannot make the contribution next year and he will lose the opportunity to get a tax deduction and get \$25,370 more into his RRSP. However, there is a way around it. John would make an RRSP contribution of \$25,370 in December. This would mean that John would have

over contributed to his RRSP.

Current rules impose a 1% penalty per month on over contributions to an RRSP. The penalty for John in December would be \$233.70 (assuming he takes advantage of the \$2,000 over contribution limit that is allowed without a penalty).

Starting January 1, 2019, John would no longer be subject to the over contribution penalty because he would have an allowable contribution limit of \$25,370 based upon his earned income from the prior year. This means that for a penalty tax of \$233.70, John can contribute an additional \$25,370 to his RRSP and receive the deduction for it in 2019. This is allowed because the carry forward rules allow an individual to make a contribution to their RRSP and deduct it at any point in time in the future based upon their earned income.

John is simply making the contribution while he still has an RRSP to allow him to take advantage of one more year of contributions.

Spousal contributions

John could also continue to contribute to a spousal RRSP after he winds down his RRSP as long as his spouse is under the age of 72 and he continues to have earned income. As well, he could take advantage of the above over contribution strategy in December of the year that his spouse must wind down her RRSPs.

Remember

For this strategy to work, an individual must have earned income that would allow them to deduct an RRSP contribution. Also, to minimize the tax penalty, the contribution should be made in December.

many things to do with Christmas - Christmas trees, Christmas Pageants, Christmas Presents, Christmas Turkeys... What is left? Christmas cards - or perhaps better - Christmas mail.

For you see, nothing distresses me more than receiving a beautiful card - obviously expensive - plus a 46 cent stamp (adding to both GST and PST) - and inside - a scrawled signature!

No "love to you and your family", or "hope this finds you well" or even "wish I had time to give you my news but I have 60 more cards to write and it's two oclock in the morning" ... just "Mary and Peter Higgenbottom" or simply "The Higgenbottoms".

What a waste! Do these people actually think that I will be deceived into believing that the syrupy sentiments penned by Mr. Hallmark are for my eyes alone? That I will fall for such phrases as "from our house to yours" or "to a very special friend at Christmas"?

The only thing worse is if the name is printed or stamped - in olde English script!

Why bother. Why not wait until the time when all the phone companies offer you a call anywhere in the world for an unlimited time for just one and half cents a second or whatever it happens to be now. Beats a card!

Then there are form letters.

Now, it is lovely to get two pages of closely printed prose from old friends - whose children you watched growing up - and whose fortunes in life you follow with the greatest of interest. But what of those letters from almost perfect strangers - whose lives are one long holiday or else an ever-ascending

career, that leave you breathless (and unbelieving). Their children captain every conceivable school team. Their average mark is A+. And from their recorded comments, they sound just a little beyond insufferable!

Lately, Christmas letters are taking on a more personal aspect. But anyone who knows anything about computers is suspicious. With blocking and rearranging, the same letter can be duplicated many times with different greetings - and endings added asking for your wife and children by name an allusion to your favourite sport or the recent death of the cat - lulling you into feeling that this letter was meant just for you!

It is rather just like those awful letters you get from a certain magazine giving you the impression that you are on the verge of winning a million dollars.

Now you know that the identical letter has been sent to half the inhabitants of the North American continent, but scattered throughout the letter are such phrases as "And Dear Mr. Armour" or "Believe Us, Incredulous Mr. Armour" or "Just Think, Unsuspecting, Stupid Mr. Armour"... until you actually believe that the million dollars has already been safely deposited in your savings account.

Which brings me to a rather good story that comes from a church in Victoria, Australia.

To produce a bulletin for a funeral of a woman named Edna, the church secretary merely updated the bulletin from a previous funeral (of a woman named Mary). By using the computer's 'search and replace' feature, every occurrence of the word 'Mary' was instantly replaced with the name 'Edna'. Imag-

ine the suppressed hilarity when the mourners dutifully following the Apostles Creed, read that Christ was 'conceived by the Holy Spirit, Born of Virgin Edna'.

When St. John wrote his Christmas Story, he described the coming Saviour as the Word of God.

And the Word became flesh and dwelt among us, and we beheld his glory, the glory as of the only begotten of the Father, full of grace and truth.

The first-Christmas card was a very personal word from God Himself - that He loves us very much and is sending us His Son, The Babe of Bethlehem, that we, hearing His words and believing them, might receive the gift of eternal life.

What shall I give so-and-so for Christmas? Why not write a long letter? Not only your news but an expression your interest in them and what is happening in their lives - an assurance at Christmas of what his or her friendship has meant to you down through the years. Life is busy - never busier than at Christmas - but life is short. What a pity if some good friend never knows the difference he or she has made in your life - that at this very special time of year, you remember and are grateful.

Silent Night, Holy Night

Recently, we were watching reruns of Downton Abbey, one of our favourite shows. It was a Christmas special and Lady Mary Crawley sang "Silent Night". Now we expected to hear the same words to a much-loved Christmas carol, but NO - the words were different! This is what Lady Mary sang:

SILENT NIGHT, holy night! Sleeps the world; hid from sight, Mary and Joseph in stable bare. Watched o'er the Child beloved and fair Sleep in heavenly rest.

Well that got me thinking a bit more about "Silent Night" and here are some interesting facts behind this much sung hymn.

"Silent Night" (German: Stille Nacht) is a Christmas carol that was composed in 1818. It is 200 years old this year! Just imagine all the millions of people who have sung those beautiful words over the past 200 years! The lyrics were written by Joseph Mohr, a young priest, and the music was composed by Franz

Xaver Gruber in the little town of Oberndorf bei Salzburg, Austria. Gruber was a schoolmaster and organist. Apparently, it was first performed with a guitar accompaniment for a Christmas Eve mass in 1818 in the former St. Nikola Church.

According to Gruber, Karl Mauracher, an organ builder who serviced the instrument at the Oberndorf church, was enamoured with the song, and took the composition home with him to the Zillertal. (The Zillertal ("Ziller Valley") is a valley in Tyrol, Austria. From there, two travelling families of folk singers, the Strassers and the Rainers, included the tune in their shows. The Rainers were already singing it around Christmas 1819, and once performed it for an audience that included Franz I of Austria and Alexander I of Russia. It made its first debut in the United States, in New York City in 1839. The rest is history as they say. The song has been recorded by a large number of singers from every music genre. The version sung by Bing Crosby is the third best-selling single of all time. (For you trivia buffs out there, Bing Crosby also has the top selling single of all time - "White Christmas"!)

One Last Traffic Safety Review for 2018

How quickly the time goes by! One minute it seems we are talking about spring and the next we are looking towards another new year. Well, Merry Christmas and Happy New Year. 2019 is just around the corner and at times like this we reflect on the past and look forward with anticipation to what the New Year brings. This is a great time to reflect on the simplicity of driving in the era when we got our driving licenses and it is also a great opportunity to review many of the changes that have happened since. In most cases, we obtained our licenses when we had two lane roadways, intersections had only stop signs, cars had only a radio and you had to stop your vehicle and go into a building if you wanted to use a phone. Marijuana was illegal.

Today our roadways are much busier and rush hour traffic seems to last all day. Speeds

are faster, everyone is in a rush and drivers are distracted. Many of us are not quite sure how we should manage the new demands of driving on more complex roadways. Today we will touch on a few of these changes and areas of concern. One of the recent changes to the law was the implementation of what is called the "Move Over Law". Intended to protect first responders and emergency personnel such as police, ambulance attendants, tow truck operators and others on the side of the roadways, it requires other motorists to slow down by at least 30km below the posted speed when approaching such scenes and to move to the left to give a safe zone to the people on the roadside. If the incident is at the median of a divided roadway, obviously you would move right. Remember, you must slow down and if at all possible you must change lanes. If you cannot safely change lanes, make sure your speed is reduced to ensure safety of those on the roadside. Not to do this can and likely will result in a ticket. It is a good practice under such situations to tap your brake a few times while slowing down to get the attention of drivers behind you and use your signal light and do a shoulder check before making the lane change. In recent years the law has been revised to enforce safety around school busses when picking up and dropping off students. You can get a hefty fine and six demerit points for passing a bus with its lights flashing. So to make it clear, if you are following a bus or you meet a bus and it activates its flashing red lights, you must come to a complete stop, whether you are on a two lane or a four lane/multi lane roadway. The only exception is if you are on a divided roadway; one that has a median, fence or something else dividing traffic in one direction from traffic in the other direction. In this case, traffic travelling in the opposite direction of the bus does not have to stop. But no matter what, always be on the lookout for children.

There is a new law coming into effect, as I write this article, which many refer to as "the One Meter Law". This was developed to provide protection to cyclists who share the roadways with motorists. If you are approaching a cyclist, you should pull safely to the outer boundary of your lane to allow at least one meter of space between your vehicle and the cyclist. For safety purposes you should slow your vehicle while passing cyclists. Remember they are very vulnerable road users.

The dedicated lane sign has become a part of our intersection vocabulary in the last few years. It is a sign which shows traffic coming straight through an intersection while other traffic is entering from the right. In this case the traffic coming straight through the intersection must stay in the left lane until it passes the solid line to its right. The traffic entering from the right has a dedicated lane and is not required to stop before passing through the intersection, thus improving traffic flow through the intersection. There are examples where traffic may be entering the main flow of traffic from the left and the left lane may be a dedicated lane. Whether traffic in the left lane wishes to be in the right lane or traffic in the right wishes to be in the left lane, all must establish themselves in their lane and wait until they are past the solid dividing line before making a normal lane change when it is safe to do so. In the Northeast Avalon there are many examples of dedicated lanes. Some examples I will highlight are the one for traffic travelling east on the Outer Ring Road and exiting onto Allandale Road and the one for traffic travelling east on Topsail Road and exiting into Mount Pearl at the Mount Carson intersection. There is one intersection in front of St. Johns City Hall for traffic heading west from Duckworth Street onto New Gower Street where, after clearing the intersection, the left lane is a dedicated lane. If you pay attention to the signage when you are driving, I am sure you will find many other examples within your commute. The key is always to stay in your lane until you are allowed to change lanes and it is safe to do so.

Impairment has always been an issue, but it has become a greater topic in recent times. While .08 has always been the benchmark for the amount of alcohol in one's blood system for impairment, a reading of .05 will land you in a lot of trouble resulting in administrative suspensions of your license and a 7 day impoundment of your vehicle. Remember, lots of older drivers find themselves facing a judge because they assumed that because they were not drunk, they were not impaired. Alcohol and many prescription drugs are a bad combination resulting in impaired behavior. And while marijuana is now legalized, its impairing effects still exist. The safest way of dealing with consuming alcohol or drugs and driving a vehicle is to keep the two activities completely separate. Don't consume alcohol or drugs and then drive!!! This was a simple but safe practice yesterday, it remains a safe practice today and it will tomorrow.

Thanks for the opportunity to highlight some safety issues one last time in 2018. Everyone here at Safety NL wishes everyone at Nalcor and Silver Lights Club a very Merry Christmas and a Happy and Safe New Year. Put on your seat belt and let's all get ready for what 2019 has to bring.

Boxing Day Tradition

In Newfoundland and Labrador, as well as in the other Atlantic provinces, Boxing Day is a general holiday. Most retailers are prohibited from opening on Boxing Day either by provincial law, a municipal bylaw or an informal agreement among major retailers. This provides many with a day of relaxation following Christmas Day. But have you ever wondered where the term "Boxing Day" comes from? (The Internet has the answer!)

It originated in the United Kingdom and is celebrated the day after Christmas Day in a number of countries that previously formed part of the British Empire. Back in the 1830's, the Oxford English dictionary defined it as "the first week-day after Christmas day, observed as a holiday on which post-men, errand-boys, and servants of various kinds expect to receive a Christmas-box".

A "Christmas box" dates back to the 17th century and meant, among other things:

A present or gratuity given at Christmas: in Great Britain, usually confined to gratuities given to those who are supposed to have a vague claim upon the donor for services rendered to him as one of the general public by whom they are employed and paid, or as a customer of their legal employer; the undefined theory being that as they have done offices for this person, for which he has not directly paid them, some direct acknowledgement is becoming at Christmas.

In Britain, it was a custom for tradesmen to collect "Christmas boxes" of money or presents on the first weekday after Christmas as thanks for good service throughout the year. This is mentioned in Samuel Pepys' diary entry for 19 December 1663. This custom is linked to an older British tradition: since they would have to wait on their masters on Christmas Day, the servants of the wealthy were allowed the next day to visit their families. The employers would give each

servant a box to take home containing gifts, bonuses, and sometimes leftover food.

So there you are. Traditions have obviously changed a lot since the 1600's!
