Re: Your request for access to information under Part II of the Access to Information and Protection of Privacy Act, 2015 (File #: PB/1268/2025)

On September 24, 2025, we received your request for access to the following records/information:

Questions on MOU between HQ and NL Hydro

- 1. Does the rate of 0.2 cents KWH, move to 5.9 cents KWH effective January 1, 2025
- 2. Is the 1 billion dollars per year we are expected to earn from now to 2041 a result of the increase from 0.2cents to 5.9 cents per KWH coming from this increase?
- 3. Or is it an advance on any future earnings we will earn now or after 2041?
- 4. If it is not either of the above, where is the 1 billion dollars extra we are to receive coming from now to 2041?
- 5. Will HQ own 33% of our water rights under these agreements?
- 6. Will NL Hydro own any portion of the new transmission lines going into Quebec?
- 7. Why have we not leveraged our position to gain access to a corridor through Quebec?
- 8. Under this new agreement effective January 2025 what will HQ pay, from January 2025 to January 2030 per KWH?

- b. January 2035 to January 2040?
- c. January 2040 to January 2045?
- d. January 2045 to January 2050?

- i. January 2070 to January 2075?

## Access or correction complaint

- **42.** (1) A person who makes a request under this Act for access to a record or for correction of personal information may file a complaint with the commissioner respecting a decision, act or failure to act of the head of the public body that relates to the request.
- (2) A complaint under subsection (1) shall be filed in writing not later than 15 business days
- (a) after the applicant is notified of the decision of the head of the public body, or the date of the act or failure to act; or
- (b) after the date the head of the public body is considered to have refused the request under subsection 16 (2).
- (3) A third party informed under section 19 of a decision of the head of a public body to grant access to a record or part of a record in response to a request may file a complaint with the commissioner respecting that decision.
- (4) A complaint under subsection (3) shall be filed in writing not later than 15 business days after the third party is informed of the decision of the head of the public body.
- (5) The commissioner may allow a longer time period for the filing of a complaint under this section.
- (6) A person or third party who has appealed directly to the Trial Division under subsection 52 (1) or 53 (1) shall not file a complaint with the commissioner.
- (7) The commissioner shall refuse to investigate a complaint where an appeal has been commenced in the Trial Division.
  - (8) A complaint shall not be filed under this section with respect to
  - (a) a request that is disregarded under section 21;
  - (b) a decision respecting an extension of time under section 23;
  - (c) a variation of a procedure under section 24; or
  - (d) an estimate of costs or a decision not to waive a cost under section 26.
- (9) The commissioner shall provide a copy of the complaint to the head of the public body concerned.

## Direct appeal to Trial Division by an applicant

- **52.** (1) Where an applicant has made a request to a public body for access to a record or correction of personal information and has not filed a complaint with the commissioner under section 42, the applicant may appeal the decision, act or failure to act of the head of the public body that relates to the request directly to the Trial Division.
- (2) An appeal shall be commenced under subsection (1) not later than 15 business days
- (a) after the applicant is notified of the decision of the head of the public body, or the date of the act or failure to act; or
- (b) after the date the head of the public body is considered to have refused the request under subsection 16 (2).
- (3) Where an applicant has filed a complaint with the commissioner under section 42 and the commissioner has refused to investigate the complaint, the applicant may commence an appeal in the Trial Division of the decision, act or failure to act of the head of the public body that relates to the request for access to a record or for correction of personal information.
- (4) An appeal shall be commenced under subsection (3) not later than 15 business days after the applicant is notified of the commissioner's refusal under subsection 45 (2).
